

I CONTINUE STUDYING AT NIU "BelSU" AFTER COMPLETING THE PREPARATORY FACULTY

I STUDY ON A CONTRACT BASIS (PAID) RECEIVED (A) certificate of completion of the preparatory faculty

- Passed the final exam at the preparatory faculty.
- Received a certificate of completion of the preparatory faculty.
- Passed successfully the entrance exams for the 1st year of the National Research University of BelSU.

I HAVE TO

- On the day the last exam result is announced, contact office 267, building 2 to **REGISTER** a training contract.
- After signing the agreement, **URGENTLY** come to the passport and visa department to prepare documents for extending a multiple-entry visa.

To extend a new visa, you must provide the following documents:

1. original passport + 2 copies of passport;
2. 2 copies of the latest visa;
3. original migration card + 2 copies of migration card;
4. original + copy of current registration at the place of residence;
5. original + copy of all pages of the training agreement with signatures of all parties and seal;
6. original + copy of the certificate of completion of the preparatory faculty;
7. original + copy of medical certificate (certifying absence of HIV infection);
8. photo size 3x4 on matte paper – 1 piece;
9. original receipt of payment of the state fee for visa extension.

**I STUDY ON A CONTRACT BASIS (PAID)
DID NOT RECEIVE (A) a certificate of completion of the preparatory faculty**

- Did not pass the final exam at the preparatory faculty, but successfully passed the entrance exams for the 1st year of the BelSU National Research University.

STUDENTS WHO DO NOT RECEIVE A CERTIFICATE OF COMPLETION OF THE PREPARATORY FACULTY ARE REQUIRED TO GO TO THEIR COUNTRY AS THEIR STUDY VISA WILL NOT BE EXTENDED.

YOU CAN ENTER TO THE 1ST COURSE ON A NEW SINGLE ENTRY STUDY VISA.

I HAVE TO

- Contact office 267, building 2 to submit documents for 1st year studies.

Documents for extending a new visa must be submitted to the passport and visa department (85 Pobedy St., hostel No. 4, office 1-15) no later than 45 days before the expiration date of the current visa.

To extend a new visa, you must provide the following documents:

1. original passport + 2 copies of passport;
2. 2 copies of the latest visa;
3. original migration card + 2 copies of migration card;
4. original + copy of current registration at the place of residence;
5. 2 copies of the referral from the Ministry of Science and Higher Education of the Russian Federation;
6. original + copy of the certificate of completion of the preparatory faculty;
7. original + copy of medical certificate (certifying absence of HIV infection);
8. photo size 3x4 on matte paper – 1 piece;
9. original receipt of payment of the state fee for visa extension;
10. certificate of training (obtain from the MFC).

WHAT CAN I DO IF I HAVE STUDYED FOR PAID AND WILL CONTINUE TO STUDY IN THE 1ST COURSE IN THE REFERRAL FROM THE MINISTRY OF SCIENCE AND HIGHER EDUCATION OF THE RUSSIAN FEDERATION (FREE)

After receiving the referral from the Ministry of Science and Higher Education of the Russian Federation in your personal account <https://education-in-russia.com>, go to office 267 building 2 to submit documents for studying for the 1st year and **URGENTLY submit documents to extend a new visa.**

To extend a new visa, you must provide the following documents:

1. original + copy of passport – 2 copies;
2. copy of the latest visa – 2 copies;
3. original + copy of migration card – 2 copies;
4. original + copy of current registration at the place of residence;
5. copy of the referral from the Ministry of Science and Higher Education of the Russian Federation – 2 copies;
6. original + copy of the certificate of completion of the preparatory faculty;
7. original + copy of medical certificate (certifying absence of HIV infection) – 1 copy;
8. photo size 3x4 on matte paper – 1 piece;
9. original receipt of payment of the state fee for visa extension;

WHAT CAN I DO IF I HAVE NOT RECEIVED A REFERRAL FROM THE MINISTRY OF SCIENCE AND HIGHER EDUCATION OF THE RUSSIAN FEDERATION

If there is NO referral on paper before JULY 31, but it is in your personal account <https://education-in-russia.com>, you need to contact the passport and visa department and report the problem (85 Pobedy St., hostel no. 4, room 1-15).

WHAT CAN I DO IF I WILL STUDY AT ANOTHER UNIVERSITY?

I AM STUDYING IN THE REFERRAL FROM THE MINISTRY OF SCIENCE AND HIGHER EDUCATION OF THE RUSSIAN FEDERATION (FREE)

Provide the passport and visa department with a new referral from the Ministry of Science and Higher Education of the Russian Federation, which will indicate the university where you will continue your studies. If there is no direction from the Ministry of Education, the migration department for Belgorod will shorten your period of stay in Russia and perhaps the new university will not be able to extend your student visa.

I'M STUDYING FOR PAYMENT

It is necessary to contact the university in advance and find out the conditions for admission to the 1st year. Bring to BelSU or send by email (petuhova@bsu.edu.ru)

LETTER OF GUARANTEE

A letter of guarantee is a letter that states that another university accepts you for study. If there is no letter of guarantee, the migration department for Belgorod will shorten your period of stay in Russia and perhaps the new university will not be able to extend your student visa.

REQUIRED DOCUMENTS FOR ADMISSION TO 1st COURSE

IF I STUDY FOR PAID

1. Copy of passport.
2. Notarized translation of the passport (notary in the Russian Federation or at the Embassy).
3. COPY of education document
4. Notarized translation of the education document (notary in the Russian Federation or at the Embassy).
5. COPY of attachments to the education document.
6. Notarized translation of attachments to the education document (notary in the Russian Federation or at the Embassy).
7. Certificate of recognition of the educational document (if necessary).

IF I STUDY FOR FREE

1. Copy of passport.
2. Notarized translation of the passport (notary in the Russian Federation or at the Embassy).
3. ORIGINAL document on education
4. Notarized translation of the education document (notary in the Russian Federation or at the Embassy).
5. ORIGINAL applications to the education document.
6. Notarized translation of attachments to the education document (notary in the Russian Federation or at the Embassy).
7. Certificate of recognition of the educational document (if necessary).
